Motion was made by Hansen and seconded by Huntley <u>to approve the 2017 10/50 and Non 10/50 Scoresheets and the Lower Elkhorn Natural Resources District – Conditional Approval Policy (November 2017) to be used in processing variance requests for new irrigated acres in the Lower <u>Elkhorn Natural Resources District</u>. (Conditional Approval Policy (November 2017) attached to official minutes.)</u>

Motion was made by Hall and seconded by Allemann to amend the Conditional Approval Policy (November 2017) on the 2018 allocation of approved Standard and Expedited Variances from 9 acre inches to 12 acre inches (total). Motion was made by Hansen and seconded by Barr to approve under the District's expedited variance process, to allow for consideration of transfer of irrigated acres district-wide, allow approval of variance applications of 10 acres or less if the addition of the requested acres will allow the applicant's center pivot irrigation system to finish its circle and to allow for the approval of qualified good cause variances and, to approve a total of no more than 100 new irrigated acres in the hydrologically connected area and no more than 100 irrigated acres in the non-hydrologically connected area for expedited variance applications located outside the District's quantity subareas for 2018. In addition, the Board directs the staff to allow for the approval of supplemental wells, only in situations where the certified irrigated acres have been severed from the sources of groundwater.
