The Information, Planning, Programs, Projects, Equipment & Legislation Committee of the Whole report was given by Roger Gustafson.

Motion was made by Gustafson and seconded by Loftis to authorize the General Manager to sign the interlocal agreement with the Village of Winslow for their Acquisition Project as presented. This interlocal agreement is for 50% of the local costs for the demolition portion of the project not to exceed \$109,562.50 of District funds. as presented. This interlocal agreement is for 50% of the local costs for the West Detention Cell and West Drainage Ditch projects along with the Rattlesnake Creek Improvement Project(not including the storm sewer removal and channel cleanout from Whitney Street up to Slaughter Avenue) not to exceed \$527,671.88. The agreement would provide funds in an amount not to exceed \$23,142.00 for the installation of drainage tile in the SE1/4 of Section 33, Township 26 North, Range 2 West in Pierce County to help drain wet areas downstream of Willow Creek Dam.
